Owner agrees to pay the rate for the playgroup in effect on the date pet is checked in. (As posted in office, and/or as indicated on this agreement.)

Owner agrees to pay all costs and charges for special services requested.

By signing this agreement and leaving your dog at Cole's K-9 Center, owner certifies to the accuracy of all information given about said dog in this agreement. Owner specifically represents that he or she is the sole owner of the dog, free and clear of all liens and encumbrances. Owner further specifies that said dog has not been exposed to distemper, rabies, or parvo-virus in the last thirty days prior to most recent play group stay.

Owner understands that some diseases cannot be vaccinated for nor identified in some animals that are carriers. His being understood Cole's K-9 Center will not be held responsible for viruses, bacterial infections or parasitic infections contracted by said dog as a result of its stay, including but not limited to coughing, sneezing, vomiting, or diarrhea.

Owner also produces written evidence that said dog mentioned on this agreement has been immunized against DHLPP, a Parvo-virus, Bordetella, Canine Influenza (H3N8) and Rabies by a licensed veterinarian.

All charges incurred by the owner shall be payable upon pick up of the dog.

All dogs play grouped, boarded, trained, or otherwise handled by Cole's K-9 Center are done so without liability on the play group part for loss or damages from disease, death, running away, theft, fire, injury to persons or other animals, or property by said dog or other unavoidable causes, due diligence and care having been exercised.

If dog becomes ill, the owner shall be notified at once in case no particular veterinarian has been designated. If the owner does not inform immediately regarding measures to be taken, or if the state of the dog's health reasonably demands quick action, Cole's K-9 Center shall have the right to call a veterinarian, as designated above or if no veterinarian is designated, to call a veterinarian, of our choice or take the dog to said veterinarian in either case; or to administer medicine or give other advisable attention, within our discretion and judgement, and such expenses, reasonable in amount, shall be paid promptly by the owner of the dog.

Cole's K-9 Center agrees to exercise due and reasonable care and to keep their premises safe, sanitary and properly enclosed. The dog is to be properly cared for and housed in clean safe quarters.

Cole's K-9 Center is not responsible for items left, damaged or lost.

Owner attests that said dog(s) has not harmed or shown aggressive/threatening behavior towards any person or dog.
